GENERAL INFORMATION

School Directors are elected by a majority of the district's citizens to operate the school system.

Although elected locally, they are state officials and representatives of the legislature. The authority vested in them by the state is only effective when acting in a body as the Board, and an individual member has no authority to make decisions or promises that are binding on the Board.

The Board of School Directors meets regularly at 7:30 p.m. on the fourth Wednesday of each month except July. Agenda meetings are scheduled for the third Wednesday of each month. Additional meetings may be scheduled as necessary. Meeting dates are posted on the bulletin board in the District Office section of the high school and in each school.

The monthly Agenda meetings and Board meetings are held in the LGI Room at the Middle/Senior High School, West Palmer Street, Morrisville, Pennsylvania.

Each month, staff members and faculty attend the meeting in order to provide information to the Board and public about programs in the School District.

Additional copies of the current Board Report are available at tonight's meeting and may be used to follow the business of the meeting as it is conducted.

MORRISVILLE SCHOOL DISTRICT GUIDELINES FOR THE CONDUCT OF PUBLIC SESSIONS DURING BUSINESS MEETINGS

Title of Board Policy

The Board of Directors of the Morrisville School District welcomes comments from the public at its regularly scheduled meetings. The following rules are designed to enhance the Board's ability' to conduct its business while allowing for public comment.

- In order to give priority to individuals who come to public meetings prepared to address the Board; a sign-up form will be available before each business meeting. All persons wishing to participate in a public Board meeting shall register their intent with the Board Secretary in advance of the meeting and include the name and address of the participate, group affiliation, if appropriate, and topic to be addressed. The Board Secretary shall collect the sign-up form immediately prior to the business meeting and give it to the Board President or Chairperson.
- II There will be one public comment session at the beginning of each business meeting related to the Business Agenda. If there is new business that is not on the agenda and will be voted-on, the Board will hold another public comment session prior to the vote. The public comments at these supplementary sessions will be limited to the new business that will be voted on.
- III. Each visitor will be allowed a maximum of three (3) minutes to present his or her statement before the Board. Each visitor is responsible for the use of his or her allotted-time.
- IV. The public session will last no longer than forty-five (45) minutes. Priority to address the Board will be afforded based on the order in which visitors indicated their intent on the sign-up form. Exceptions to these time limits can be made by the President or Chairperson based-on special circumstances, following consultation with the Board.
- V. The presiding officer shall be guided by the rules established by the Board.
- VI. Whenever issues identified by the participant are subject to remediation under policies and procedures of the Board, they shall be dealt with in accordance with these policies_and procedures.

Participants must be recognized by the presiding officer and must preface their comments by an announcement of their name, address, and affiliation if appropriate.

No participant may speak more than once on the same topic unless all others who wish to speak on that topic have been heard, and only with permission from the presiding officer.

- VII. Certain topics are-not appropriate for, and, therefore cannot be open to, sessions of the Board. These include, but are not limited to: student discipline, personnel issues, contractual problems and other topics that could result in litigation. Furthermore comments that include obscenities, personal attacks, abusive language, and business not germane to the business of the School District of the Borough of Morrisville will not be tolerated.
- VIII. The presiding officer may:
 - a. Interrupt or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant.
 - b. Require any individual to leave the meeting when that person does not observe reasonable decorum.
 - c. Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting.
 - d. Call a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action.
