Dr. Yonson advised that administration has reviewed budget requests and administration has been directed to find ways to decrease costs. This Act 1 resolution timeline requires it be done by tonight.

Mr. Buckman reported that he attended the tech school budget meeting tonight and tech intends to freeze or decrease Morrisville's contribution for next school year.

Mrs. Mihok advised that the BCIU has locked in a fuel rate of \$2.34/gal. The IU expects a 4.04% reduction in their budget. Mr. DeAngelo advised that Morrisville has not locked in fuel costs because we are uncertain what our needs will be for the next school year.

Mr. Kemp asked if we are on target with the 08-09 budget. Mr. DeAngelo advised we are a little behind where we would like to be right now. He expects to update this information at the January 28th meeting. I will be coming to the board with a barebones budget.

Mrs. Mihok related a request she received to place signage on school district vehicles.

ADDITION TO AGENDA

Reappointment of IU representative to Board of Directors. Authorize bids for work at high school (related to Vitetta's proposals). Proposal from Vitetta Engineering to upgrade Grandview Elementary.

Mrs. Reithmeyer asked if we want to go ahead with this since the insurance company is willing to compensate for new boilers at Reiter and the fact that Reiter is centrally

located and the larger facility.

In order to prevent a boiler mishap in the future, Mrs. Reithmeyer suggested that we should investigate why it happened. Mr. DeAngelo advised that the insurance company sent out an investigator. It is obvious that the solenoid failed and the recommendation is to replace both boilers to prevent this from happening again. Dr. Yonson related that the forensic engineer stated that no one was at fault here and this was accidental; a report will be forthcoming.

The Bucks County Technical School dinner will be held Monday night. Dr. Yonson will be in Harrisburg; however, she will have someone introduce the board members at the meeting.

Modular Classrooms – Mr. DeAngelo advised that footers are finished and must cure for 7 days. Electrical work has begun. Plumbing has begun. Unfortunately, the weather is a hindrance for curing.

Ms. Ruffing advised that we have been able to enter Reiter and we are working closely with the cleanup crew. We are retrieving teaching materials.
