- Mrs. Mihok stated she received a letter in her mailbox from Robin Reithmeyer stating that all renovation funds have been spent. Mr. DeAngelo outlined the status of funds for construction/renovation. There was 7+million dollars in the account. Those monies are still there less the expenditures of 3+million that has been spent. That money has been allocated but not spent. We paid architect fees, electrical fees, 50% of MJF's bill (\$58,000), and general contractor bonds. None of the money for construction has been spent. It is still in our bank.
